NORTHWEST MO MODEL A FORD MEETING American Legion Hall Smithville, Missouri November 7, 2022

Larry Harding (President) started the meeting at 7:03 p.m. with the Pledge of Allegiance. He recognized all the veterans that were present for their prior service. There were five veterans in attendance. Larry announced that Jim Shaw has a new phone number: 816-868-5801.

The first subject was a discussion of the proposed 2023 budget. The proposal reflects the reality that prices have risen quite a bit in the last year. The Board worked hard to create a more realistic and accurate budget, so hopefully there will be fewer requests for additional funds throughout the year. Larry went over the numbers, and the reasoning behind them. The budget is focused on keeping the club interesting for current members and also on working on bringing in new members. More money was allotted to entertainment and activities for these reasons. These events help keep the club going. Other sections, such as the Road Runner, were able to lower their budgeted amount, even with the increased cost of postage. Larry also pointed out that the club appreciates that some members are willing to cover some expenses out of pocket for the benefit of the club, but ideally these activities should be covered by a proper budget. Members already spend many uncounted hours of behind-the-scenes work, which is greatly appreciated, and they should not need to dip into their own pockets to fund these events. The discussion also included the loss of memberships, and other factors that were considered to reach the final budget number presented tonight.

Continuing the discussion regarding the budget, it was stressed that Board members will be accountable and that any money spent will be within the rules of the club. The Board voted unanimously to bring the final budget proposal to the full membership. Myron Schmidt asked if we should raise dues to account for some of the changes. Bob Martin said that we would have to change the bylaws to change dues. He said dues barely cover the cost of printing Road Runner. Myron asked why we are losing members. Bob said it was due to COVID and internal problems that started back in 2015, health issues, and members getting older. Myron pointed out that younger people don't have the money to buy cars in today's economy. Terry Richardson reviewed that the club started at Lowman's Café and grew quickly early on, and he feels like we need to do something to get younger members. Chili Canida asked how much it would save by not printing Road Runner. Multiple members indicated that they enjoy the printed version. The numbers as to cost savings were not available at this time. Myron wanted to know if, since last year we didn't charge dues, we couldn't just ask everyone to put in an extra \$5.00. Bob said that the authority for an organization starts with the club. He said the Board would need to take a look at this idea, and come back with a proposal. Any request such as this would need the approval of the membership to be implemented. Tony Fleig asked if anyone asked the members why they quit. He suggested that we try to get sponsors or maybe call Gary Crossley Ford and have a Model A car show to get the word out. Bob said that many things are already in progress, but ideas are always welcome. Mike Owen made a motion to vote on the budget. Les Gust seconded the motion. The budget was part of the voting ballot completed later in the meeting. Tony Fleig asked if budget is approved, it means this is what we can use? The answer was yes, and the budget would be reassessed next year. Larry said that anyone can question a budget report.

General election: Larry read the names of the officers to be voted on who are on the ballot and said there were write-in-spots if you want to nominate someone not listed. Myron Schmidt said that he would volunteer to be on the board. Larry said that any member is welcome to come to the board meeting and/or let the incoming President know their willingness to serve in an appointed position.

Bylaw Changes: Bob Martin came up and talked about the proposed bylaw changes that were printed in the November Road Runner. The following people were members of the bylaw committee: Bob Martin, Chair, Sherry Winkinhofer, Terry Richardson, Malcolm McIntyre and Raul Salmon. Bob said that our previous bylaws were very sound, but a few adjustments were proposed. Each committee member did an independent review of the bylaws and then shared areas that they felt should be looked at. The proposed changes include the following: The quorum is better defined, and changed to a percentage instead of a number. Directors position changed back to be the last two previous Presidents (the positions were established to benefit from the experience of previous presidents in supporting the club. The Vice President's financial review is changed to a formal audit to keep in good standing with members and the state. Appointed Positions – changed so that only the President can appoint positions. The new budget will now need to be approved before January 1, 2023. Dissolution of funds-in the event the club ceases to exist, all remaining funds would be directed to the Model A Restorers Club Youth Scholarship Fund and/or the Model A Restorers Club Youth Restoration Fund. The process for the removal of an officer has been added, with strict guidelines. Because of the lessons learned from COVID, the ability to vote by mail has been added, to be used only in extreme circumstances. clarified that an officer may not hold more than one office at the same time. The Vice President automatically moves into the president's position the following year, removing the option of the president holding office for more than one consecutive year.

Jeanne asked if, on the vote on the bylaws, it will be an all or none by approved. She was told yes, either all or none. John Kunkle thinks the bylaws should be brought up and voted on changes individually and we should be able to approve only parts. Larry stated that the board has determined that it must be voted on as a whole, and that any changes must be considered later.

Fred Kiehl asked that if we vote and the bylaws don't pass, then at a later meeting we could we address individual parts. Larry said that while everyone needs to be heard, the bylaws committee spent most of the year on this review, and he appreciates their time. Additional club members questioned why each change couldn't be voted on separately, and a long discussion ensued. Bob emphasized how hard the committee worked for months to come up with this proposal. Larry finally had to call time on the discussion and recommend that if you think the overall Bylaw proposal is good, vote for it, but if you don't, vote no, and if the vote

Five Quarts of Oil?

From the July 1999 Issue of Quail Mail:

Every Model A capacity chart that has ever been printed indicates that the Model A engine holds 5 quarts of oil. No indication is given whether this is the initial fill or the amount needed when changing oil. It is assumed that the dipstick is the only true indicator to determine exactly how much oil is in the crankcase.

Unfortunately, Ford did not choose to inscribe any guidelines on the dipstick. So unless there is an exception, all Model A dipsticks have only an "F" stamped at the proper level. By measurement, this is a 1 1/2 inch distance from the bottom of the dipstick, presumably to guide those who do not know that no oil on the stick means that the oil supply is low.

There are also several styles of dipsticks, but the outside handle configuration of the stick portion appears to be the same. We're not into changing oil much, depending on the amount of driving, maybe it's once a year. Oil doesn't really wear out. It becomes contaminated with gas and crud generated by low or high engine heat—a problem usually caused by short drives, excessive idling, and atmospheric temperatures. When we do change oil, it has always taken 5 quarts or less to get the level to the "F" mark. The problem is that when drained, some oil remains in the valve section below the distributor, which means that there is more than 5 quarts of oil in the engine. Sometimes the dipstick shows more above the "F" marker after it's driven. Probably the best method when changing oil is to add about 4 quarts, run the engine, and then pull the dipstick to see the oil level.

Adolph Rickenbacher and George Beauchamp founded Ro-Pat-In Corporation (ElectRo-Patent-Instruments) in 1931 to sell electric Hawaiian guitars. Beauchamp was a vaudeville performer who wanted to make his guitar louder. In 1928, he and partners opened the National String Instrument Corporation to make guitars, mandolins, and ukuleles. Rickenbacker ran a metal stamping shop and was a skilled engineer and machinist. His company was hired to make

In 1931, a group including Beauchamp and Rickenbacker formed the Ro-Pat-In Corporation (elektRO-PATent-INstruments) to make and sell electrically amplified musical instruments, which were the first solid body electric guitars. In 1933, the Ro-Pat-In company's name was changed to Electro String Instrument Corporation, and its instruments were labeled simply as "Electro." In 1934, the name "Rickenbacker" was added. The company's instruments went on to become the favorites of many musicians, especially during the rock and roll years.


Walt's Old Time Tech Tip

As printed in the Model A News, newsletter of the Model A Club of Queensland:

Tillotson and Marvel Carburetors.

The mounting threads on Tillotson and Marvel alloy carburetors are normally found stripped and the alloy flange bent and distorted. This is a fix I have used to correct the problem. First, two (2) flanged sleeves are turned from piece of 3/4" or 18mm round (the exact size is not critical,) to the dimensions in figure 1



The sleeve has a 5/16 UNC thread tapped through which is the same size as the mounting bolts. With the Tillotson, one has a flange side removed to allow it to fit, but on the Marvel the 4mm flange remains intact for both.



FIG₁ The stripped mounting Flange threads on the Tillotson and Marvel Carburetors are drilled to 10mm and the underside of the

flange skimmed flat (I did mine with a slitting blade in a mill but it could also be filed flat). The sleeves are pulled in to the flange using a bolt and spacer washer and electric screwdriver. Figure 2. Both in a Marvel, Figure 3. and the flat sided one on a Tillotson, Figure 4.

The top of the carburetor is then mounted in a mill and the top skimmed to make the top surface flat and the excess sleeve is removed in the process. See Figure 5 and 6. and finished, Figure 7

The flange stops the sleeve from pulling through and increases the clamping area as well as providing more thread area.

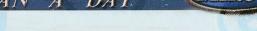

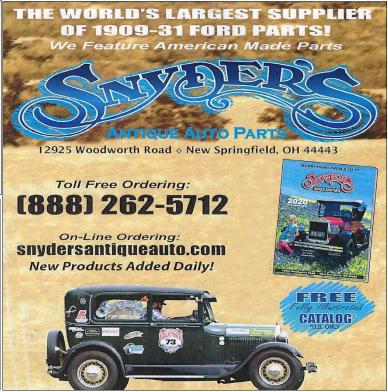
